### **Independence**

Every grade six student in Calgary is eligible to receive a free YMCA 13-month membership to the YMCA, thanks to the generous support of the Calgary Flames Foundation. August 01, 2024 – August 31, 2025

The program supports youth as they transition/age out of traditional childcare models, develop new interests and prepare for junior high. It gives youth a safe place to practice independence, develop healthy habits, and establish a sense of belonging in a centre of community that promotes the values of respect, honesty, caring and responsibility.

### **Program Information and Benefits**

Students keep active and gain independence, as members can visit any YMCA locations on their own, without a parent/guardian. Grade 6 members can participate in both independent and programmed activities including open swim, special events, tournaments, weekly planned activities, and Flames Friday sports nights.

### **What's included with the Grade 6 Program?**

- A free YMCA membership for the Grade 6 school year
- Access to all YMCA locations
- Flames Friday activities, intramurals, weekly fitness classes, game nights and other programming. (See the monthly schedules at each YMCA location.)
- Grade 6 city-wide tournaments and special events
- All the great benefits that come from being a YMCA member, including discounts up to 25% on programs and day camps
- One free guest admission every month

Bring your form along with your Grade 5 report card, school ID or a signed letter from a school administrator or teacher to any YMCA location. A customer services team member will provide your child with a membership card, details on our Grade 6 Member Orientation, how to access program and event schedules and more.

### Facility & Age Guidelines

The YMCA is a shared experience for everyone to enjoy. Members must respect the rights of all others. At YMCA Calgary, all paths lead to our four core values of respect, caring, honesty, and responsibility when using the facilities and programs. Unsafe, disrespectful, or inappropriate behaviour may result in the removal of privileges and/or memberships

- Grade 6 members may access the facility without a parent/guardian\* and are expected to follow the four core values of the YMCA at all times
  - \*Grade 6 members 10 years and older may independently access all YMCA facilities
  - \*Grade 6 members must complete an orientation with weight floor staff, before accessing the weight floor in each YMCA facility.
- Before accessing the facility, we encourage members to review the facility schedules to ensure age appropriate activities are available
